#### WELCOME!

We are glad you have joined us for today's meeting. The Baldwin Park Town Design Review Committee (TDRC) is an advisory board to City Council that reviews proposed development within the Baldwin Park Planned Development (PD) in accordance with the adopted PD ordinance. All TDRC Recommendations are subject to final action by City Council. Any person desiring to appeal a recommended action of the Committee must file such appeal by Thursday, March 31, 2022. The appeal would be considered by the Municipal Planning Board at their meeting on Tuesday, April 19, 2022. We anticipate that the minutes of today's meeting will be presented at the City Council meeting on Monday, April 25, 2022, for approval of recommended actions. CAUTION: Untimely filing by any appellant shall result in an automatic denial of the appeal.

In response to the COVID-19 pandemic social distancing efforts, City Hall is closed to the public and there is no physical location to attend this meeting in person. We encourage members of the public to participate by watching the virtual meeting online or listening by phone and providing live public comment or submitting written public comment in advance. #### WRITTEN PUBLIC COMMENT

Written public comments received 24 hours in advance of the meeting are distributed to Baldwin Park TDRC and attached to the related agenda item for public viewing. Note: Comments that do not include the required information will not be distributed or attached to the agenda. All comments received are public record.
