

Downtown South Neighborhood Improvement District Goals, Objectives and Performance

December 1, 2025

Purpose

In 2024, the Florida Legislature passed HB 7013, which among other expectations, requires all special districts to adopt goals and objectives for each program and activity undertaken by that district, as well as performance measures and standards to determine of this document is to satisfy those statutory requirements by formally:

- (1) listing the programs and activities undertaken by the Community Redevelopment Agency;
- (2) stating the goals and objectives of the Agency in connection with those programs and activities; and
- (3) objectives are being achieved.

The purpose of this Annual Report is to summarize the Downtown South Neighborhood Improvement District's (DSNID) goals, objectives, and accomplishments during Fiscal Year 2024/2025. As a special district established to support coordinated improvements in the Downtown South area, the DSNID provides a focused structure for guiding investments in infrastructure, safety, mobility, and economic vitality.


The DSNID was created to monitor and advocate for the interests of business and property owners within the SoDo area. Through coordinated planning, funding, and partnerships, the district serves as a conduit for long-term improvements that enhance mobility, public safety, and the overall economic environment.



Overview

The Downtown South Neighborhood Improvement District was established by Ordinance No. 2011-28 to advance public improvements and support the continued redevelopment of the SoDo area. Covering approximately 720 acres, the district provides a formal organizational structure through which local businesses, property owners, and public partners can collaborate to address infrastructure needs, safety enhancements, multimodal mobility, and district identity.

The DSNID plays a strategic role in advocating for transportation upgrades, streetscape improvements, active transportation options, and economic development initiatives. Through its partnerships with the City of Orlando, FDOT, MetroPlan Orlando, and community organizations, the district works to advance projects that strengthen SoDo's function as a major activity center within the Orlando urban core.





Mission

The mission of the DSNID is to promote the long-term vitality of Downtown South by advancing projects and initiatives that improve safety, mobility, infrastructure, and economic opportunity for the businesses, property owners, and residents who make up the district.

Vision

The DSNID envisions a well-connected, economically vibrant district where multimodal transportation, public infrastructure, and strategic redevelopment support a thriving urban environment that enhances the quality of life for all who visit, live, or work within the SoDo area.

Introduction

Fiscal Year 2024/2025 represents a period of ongoing project advancement for the DSNID, with continued progress on major roadway improvements, multimodal connectivity initiatives, and economic development support. The DSNID's work reflects the priorities of the district's stakeholders and the collaborative efforts of partner agencies.

Background

The DSNID operates as a dependent special district within the City of Orlando. Its initiatives are shaped by the needs of Downtown South's property owners, businesses, and visitors. During FY 24/25, the district continued to focus on infrastructure enhancements, mobility improvements, and support for economic activities that contribute to a more connected and dynamic urban environment. For Fiscal Year 2024/2025, the millage rate levied was 1.000 mill.

Throughout FY 24/25, the DSNID continued advancing major mobility and infrastructure initiatives.

- Orange Avenue Complete Street Rebuild S Orange Avenue Complete
 Streets is officially completed, creating a safer and enjoyable atmosphere for
 pedestrians on the major road within the district.
- Support for SoDo Main Street The DSNID contributed with \$30,000.00 to the SoDo Main Street District. SoDo Main Street spent this amount through preestablished categories such as Economic Development/Vitality, Creative & Environment, and Marketing. To name a few initiatives, The Main Street maintained the SoDo Plaza Art Projection, funded the Squeeze of the Month program that helps highlight businesses within the District, and replaced the branded street banners throughout the district.
- Community Events & Engagement The DSNID was the sponsor of the 9th
 Light Up SoDo event, which takes place annually. Light Up SoDo took place on
 December 7th 2024 at the KimCo's SoDo Shopping Center, bringing several
 local vendors to the family and pet-friendly holiday event. In addition to Light Up
 SoDo, the DSNID also contributed with marketing & branding materials
 distributed on the City of Orlando 150th Anniversary celebration held in the
 district on July 19th, 2025.
- O-Line Bike & Pedestrian Project The DSNID funded the engineering advancement of the O-Line Bike & Pedestrian Trail, and it is actively working with VHB, Inc. to deliver the final drawings as well as construction cost estimates by October 2026. Stakeholder engagement meetings will kickstart in early 2026.
- Columbia Street & Sligh Avenue Improvements This is a multi-agency project, affecting timelines. This project recently received the Notice to Proceed from FDOT and is expected to go out for bids in Mid-December 2025.
 Construction set to start in April 2026, with a completion date of April 2028.



2026 Goals, Objectives and Performance Standards

The DSNID will continue prioritizing multimodal connectivity, public infrastructure, and economic development partnerships. Future efforts will focus on enhancing SoDo's identity, improving district accessibility, and advancing capital projects through interagency collaboration.
